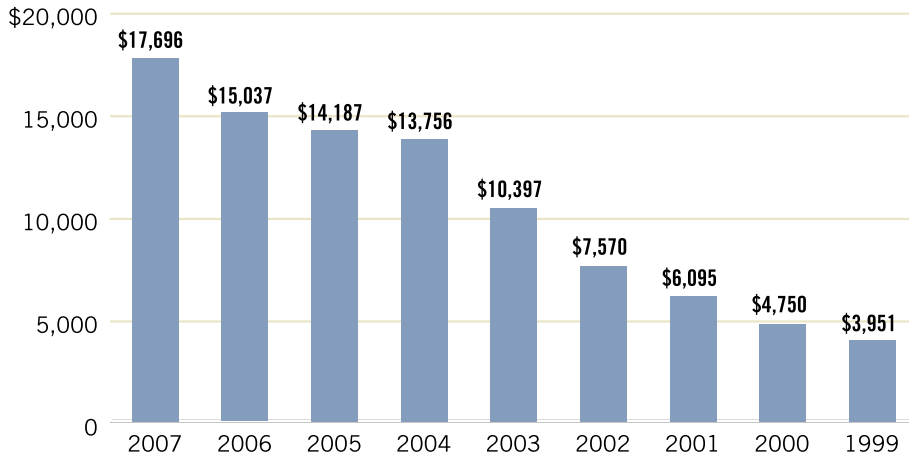


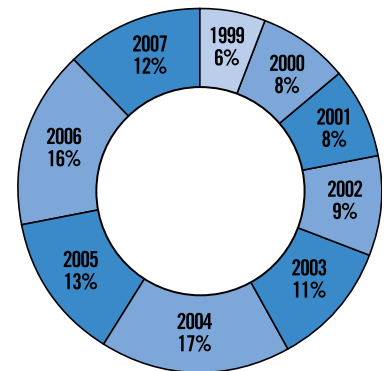
Average AuctionNet price
