

**Written Statement of  
62 State and Metro Automobile Dealer Associations**

Submitted to the U.S. House of Representatives

Committee on Ways and Means

For the Hearing Titled, "Paving the Way for Funding and Financing Infrastructure Investments"

January 29, 2020

Mr. Chairman, thank you for the opportunity to submit comments on the future of federal infrastructure funding. Our trade associations represent new car and heavy-duty truck dealerships across America. Nationally, heavy-duty truck dealerships employ more than 144,000 Americans in good-paying jobs, providing economic security and opportunity for employees' families and communities. As Congress considers comprehensive infrastructure legislation and potential changes to how the Highway Trust Fund (HTF) is funded, we urge the Committee to repeal the federal excise tax (FET) on the sale of new heavy-duty trucks and trailers and replace it with a more fair and consistent revenue source that does not discourage the adoption of cleaner, more fuel efficient, and safer trucks.

The FET was first enacted in 1917 to help fund the cost of World War I. This tax began as a 3% levy and has ballooned to 12%. Recent environmental and safety mandates have added nearly \$40,000 to the price of a new truck, and the FET also taxes those regulatory costs. The FET, now the largest tax Congress imposes on a percentage basis, has not been modified by Congress since 1982. The FET is an upfront charge, and this tax can add more than \$22,000 to a truck's sale price. The tax is also inequitable, as it does not reflect road use or impact over the lifetime of a truck.

Additionally, the FET has also been the most inconsistent revenue stream paid into the HTF over the past twenty years, ranging from as low as 3.7% of total HTF receipts in 2008 to as high as 10.9% in 2015. As FET collections are dependent on fluctuating annual truck sales, the volatility of this revenue contributes to the overall instability of the HTF.

For these reasons, we urge the Ways and Means Committee to repeal this outdated tax. By repealing the FET and identifying a viable, equitable source of replacement revenue, Congress can encourage the deployment of today's safer and cleaner heavy-duty trucks onto America's roads. We urge the committee to modernize America's truck fleet by repealing the FET. Thank you for your consideration.
