NADA PAC ensures that the voice of new-car and -truck dealers is heard on Capitol Hill, supporting pro-dealer, pro-business Congressional candidates on a bipartisan basis.

What is the Presidents Club?

The Presidents Club was established in 1987 to recognize dealers who significantly support the mission of NADA PAC.

Membership in the Presidents Club requires an initial donation of \$5,000 to NADA PAC, and can be renewed each year with a \$2,500 donation.

Family members and eligible dealership personnel of current Presidents Club members may join for an initial \$2,500 donation.
